AVIATION RESCUE FIRE FIGHTING SERVICES (ARFFS)

Airservices qualified aviation rescue firefighters participate in operations involving the rescue of people from an aircraft that has crashed or caught fire during landing or take-off. They control and extinguish fire and protect people and property threatened by fire on the airport in general.

An aviation rescue firefighter's primary role includes:

- assisting in the evacuation of people in life-threatening situations using mobile high performance vehicles and watercraft;
- fighting fires using a range of equipment;
- administering first aid;
- · protecting property endangered by fires;
- protecting the environment (as necessary) in an emergency situation;
- · participating in organised drills for fire control and rescue work;
- testing and maintaining fire vehicles and other equipment;
- operating the Airservices Fire Control Centres at airports.

The PUA20619 Certificate II in Public Safety (Firefighting and Emergency Operations) will develop your skills and knowledge to perform the role of an aviation rescue firefighter. Successful completion of this qualification will provide you with a nationally-recognised qualification.

THE TRAINING PROGRAM

Aviation rescue firefighting is an exciting and rewarding career. It is also challenging and demanding with specific regulatory and safety requirements to be met.

If you are successful in applying for an Aviation Rescue Fire Fighting Services (ARFFS) position with Airservices, you will be required to complete the PUA20619 Certificate II in Public Safety (Firefighting and Emergency Operations) before your placement at one of our ARFFS stations within Australia.

The training program is designed to provide you with the necessary skills and knowledge to commence your career as an aviation rescue firefighter. Your training will cover:

- injury prevention;
- · responding to aviation incidents;
- working in a team;
- operating breathing apparatus;
- · operating equipment.





WHO SHOULD APPLY?

To be eligible for an Airservices aviation rescue firefighter role, applicants must meet the following minimum entry standards:

- · be at least 18 years of age;
- be an Australian or New Zealand Citizen or hold Australian Permanent Residency;
- pass the physical aptitude test;
- hold a current water competency qualification (e.g. Bronze Medallion) or have the ability to undertake and pass an ARFFS water competency assessment prior to the assessment centre (this requirement applies to stations with water rescue equipment);
- hold or obtain a current HLTAID011 Provide First Aid or HLTAID014 Provide Advanced First Aid certificate or equivalent prior to commencement of the recruit course;
- hold a current unrestricted full manual driver's licence and the ability to gain a heavy rigid license at least four weeks' prior to commencement;
- · pass all pre-employment checks.

There are no training package pre-requisites for entry into this course.

HOW TO APPLY

UNIQUE STUDENT IDENTIFIER

All students enrolled in nationally recognised training are required to hold a Unique Student Identifier (USI). Whether you already have a USI or need to obtain one, you will need to share your USI with Airservices Australia RTO 5168. Further information will be provided during the recruitment process for external students, or with your joining instructions for pathway students.





PROGRAM OUTLINE

The Certificate II in Public Safety (Firefighting and Emergency Operations) is a nationally recognised VET qualification. The program duration is 15 weeks. The training entails theory and practical activities to provide you with the skills and knowledge to perform the role of an aviation rescue firefighter.

The program covers the following units of competency:

- PUAOPE013 Operate communications systems and equipment
- PUATEA001 Work in a team
- PUAFIR203 Respond to urban fire
- HLTAID011 Provide First Aid
- PUAFIR210 Prevent injury
- PUAEQU001 Prepare, maintain and test response equipment
- PUAFIR207 Operate breathing apparatus open circuit
- PUASAR022 Participate in a rescue operation
- PUACOM001 Communicate in the workplace
- · PUATEA004 Work effectively in a public safety organisation
- PUAFIR206 Check installed fire safety systems

Additional elective units included as part of this training are:

- PUAFIR204 Respond to wildfire
- PUAFIR205 Respond to aviation incident (specialist)

During your initial 15-week training program, the following eight units will also be delivered and contribute to a Certificate III qualification to be completed at the station:

- PUAFIR309 Operate pumps
- PUAFIR308 Employ personal protection at a hazardous materials incident
- PUAFIR324 Render hazardous materials incidents safe
- PUAWHS002 Maintain safety at an incident scene
- HLTAID015 Provide Advanced Resuscitation and Oxygen Therapy
- PUAFIR310 Operate specialist appliance
- HLTAID014 Provide Advanced First Aid





HOW IS TRAINING DELIVERED

The training is delivered at Airservices ARFFS Training facility located in Melbourne. We deliver the training face-to-face through classroom theory sessions and practical activities that are conducted at our multi-million dollar, purpose-built Aviation Fire Training Ground. Facilities and equipment required for you to complete your training will be provided.

Throughout the training you will have the opportunity to develop the skills that you learn and you will be assessed for competence against each unit included in the program.

The training does not stop here. You will continue to develop your skills at your station with your crew and undertake further training and assessment in order to obtain your Certificate III qualifications.

WHO WILL DELIVER THE TRAINING?

Training is delivered by qualified Airservices ARFFS Training Officers, who are specialised learning and development professionals with extensive training and industry experience.
